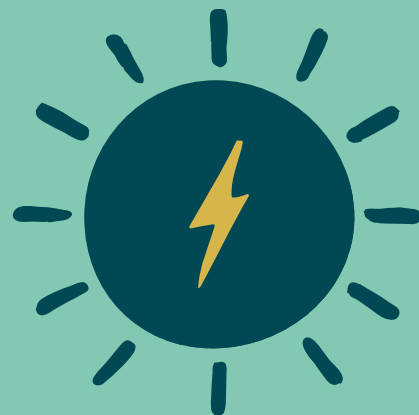
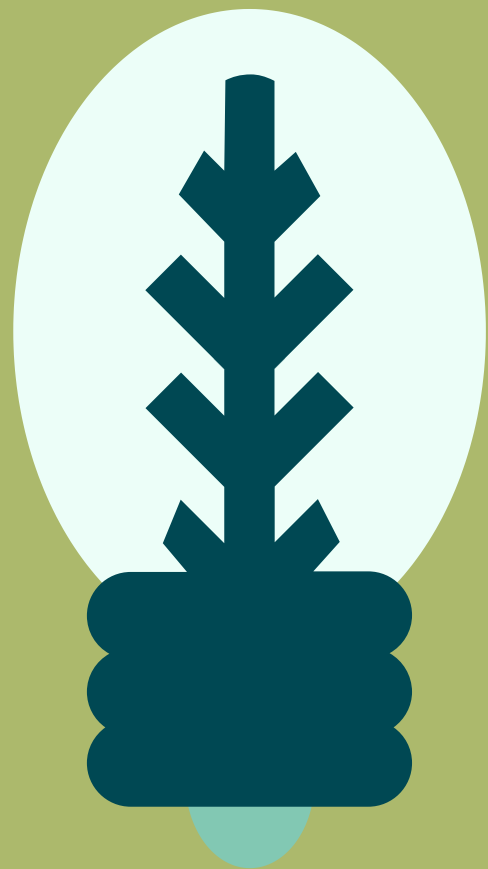

- Promote equality through taxation, labor market policies, and social protection programs.





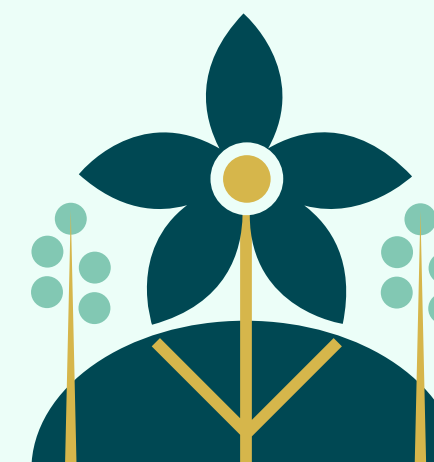

Justice Department: Students Benefited Effectively from the Mobile Office

🏛️ Within the framework of the “We Came Ourselves” project, employees of the State Services Center under the Navoi City Department of Justice provided public services through a mobile office to the professors, teachers, and students of the Faculty of Preschool and Primary Education at Navoi State Pedagogical Institute.

During the event, 32 student requests were successfully processed, including services such as dormitory registration, Mobile ID activation, applications for 12% income tax refund on tuition payments, registration of children for preschool education institutions, subsidy applications, and obtaining electronic signatures.

Interview Process for Citizens with Professional Experience in Economic Sectors



In accordance with the instructions of the State Commission for Admission to Educational Institutions of the Republic of Uzbekistan and the Ministry of Higher Education, Science, and Innovation, interviews were held for citizens with at least five years of work experience in economic sectors to be admitted to bachelor's degree programs in distance and evening study modes.



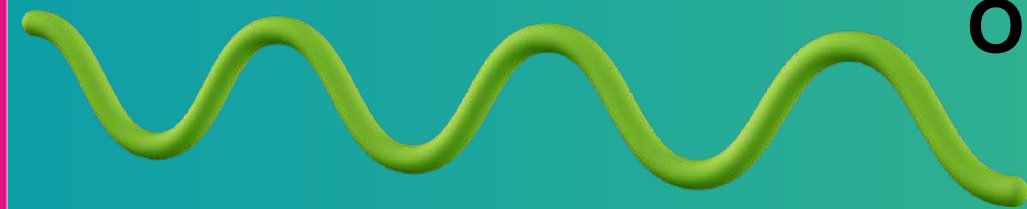
The interviews were organized by the university following the established procedures, during which the candidates' knowledge, skills, and professional experience were evaluated.

Improving Living Conditions to Ensure Equal Opportunities for Students



In line with the Sustainable *Reduced Inequalities*, Navoi State University consistently works to create equal living and learning conditions for all students. Nearly 1,300 students currently reside in university dormitories located across the city, where efforts are made to provide a safe, comfortable, and inclusive environment.

This initiative demonstrates the university's commitment to reducing inequalities by ensuring that every student—regardless of background or financial status—has access to quality living conditions and equal opportunities for success.



During the recent visit, the university administration, led by Rector M. Kalonov, held open discussions with students to assess their living conditions, food and energy supply, hygiene, and safety standards. Identified issues were addressed on the spot, and responsible departments were given specific instructions for further improvements.





Redistributing Financial and Economic Resources to Reduce Inequality



Law “On Employment of the Population” (2020)

This law establishes a framework for ensuring employment through structural, financial, credit, investment, and tax policies. It aims to create equal opportunities in the labor market and reduce unemployment, especially among youth and women.

Tax for SDGs Initiative

The UNDP, together with the Ministry of Economy and Finance and the Tax Committee under the Cabinet of Ministers, launched training courses and policy dialogues on “Taxation and the SDGs.” These initiatives focus on strengthening fair and sustainable tax systems that support equality and efficient redistribution of financial resources.

Reducing Informality and Strengthening Social Protection

The Government of Uzbekistan has introduced major reforms to formalize employment, expand social protection coverage, and ensure equal rights in the labor market. These actions aim to reduce inequality by providing legal and financial support to vulnerable groups such as women, youth, and low-income workers.

Targeted Social Assistance Programs

The National Agency for Social Protection (NASP) implements programs providing financial and social aid to low-income families, people with disabilities, and the elderly. These initiatives ensure that economic resources are redistributed fairly toward those most in need.

The implementation of Reduced Inequalities — plays a crucial role in ensuring inclusive and sustainable development in Uzbekistan. This goal focuses on promoting social, economic, and political inclusion for all individuals, regardless of age, gender, disability, ethnicity, origin, or economic status.

Uzbekistan has been actively pursuing policies to reduce inequalities through fair redistribution of financial and economic resources, progressive taxation, labor market reforms, and social protection programs.
